

**Use this form for:**

- 90-Day Election Cycle Reports
- Ballot Measure Independent Expenditure Reports
- 16-Day Late Independent Expenditure Reports

**90-Day Election Cycle Reports**

- Independent expenditures that cumulatively total **\$1,000 or more** to support or oppose a **single candidate for elective state office or a single state ballot measure** must be reported during the 90-day election cycle. “Election cycle” means the period of time beginning 90 days prior to the candidate’s or measure’s election and ending on the date of the election.
- File Form 496 electronically with the Secretary of State within 24 hours of making the independent expenditure(s). No paper copies are required and no copies are required to be filed with other filing officers.

**Ballot Measure Independent Expenditure Reports**

- At all times other than the 90-day election cycle, independent expenditures that cumulatively total **\$5,000 or more** to support or oppose a **single state ballot measure** must be reported.

- File Form 496 electronically with the Secretary of State within 10 business days of making the independent expenditure(s). No paper copies are required and no copies are required to be filed with other filing officers.

**Late Independent Expenditures Supporting/Opposing Local Candidates and Local Ballot Measures**

- Independent expenditures that cumulatively total **\$1,000 or more** to support or oppose a single candidate for local elective office or a single local ballot measure during the 16 days immediately preceding the election in which the candidate or measure will be voted on must be reported as **late independent expenditures**.
- File Form 496 within 24 hours of making the independent expenditure(s) with the filing officer(s) who would receive your campaign statements if you were a committee primarily formed to support or oppose the candidate or ballot measure.
- File Form 496 by fax, guaranteed overnight delivery, or personal delivery. **Regular mail may not be used.** A local ordinance also may require this form to be filed electronically.

***What is an “independent expenditure”?***

An “independent expenditure” is an expenditure made in connection with a communication (e.g., a billboard, advertisement, mailing) that expressly advocates the nomination, election, or defeat of

a clearly identified candidate or the qualification, passage, or defeat of a clearly identified measure. An independent expenditure is a payment that is not made to—or at the behest of—the affected candidate or committee.

**How to Complete Form 496**

**Report Number.** Assign a unique identifying number to each Form 496 report that you file. You may use any numbering system (such as 1, 2, 3, PR-1, PR-2, PR-3).

**Amendments.** To amend an electronically filed Form 496, describe the amendment in the space provided at the bottom of the form.

**Part 1. Candidate or Measure.** Identify the candidate or ballot measure supported or opposed. Be sure to include the candidate’s district number (if any) or the letter or number of the ballot measure. Use a separate form for each candidate or measure. (Example: A committee makes an independent expenditure by running an advertisement opposing two candidates. The ad costs \$4,000 and features the candidates equally. The committee must file a separate late independent expenditure report for each candidate and disclose \$2,000 for each candidate.)

**Part 2. Independent Expenditures.** Provide the date, amount and a description of the independent expenditure made (e.g., radio advertisement, billboard, mailing).

**Part 3. Contributions Received.** Disclose contributions of \$100 or more received since the closing date of your last campaign statement (Form 450 or 460) through the date of the independent expenditure. If no previous campaign statement has been filed, disclose contributions of \$100 or more received since January 1 of the current calendar year.

Disclose the name and address of the contributor and, if the contributor is an individual, his or her occupation and the name of his or her employer. If the contributor is self-employed, disclose the name of the business. Also disclose the date and amount of the contribution, the contributor code, and type of contribution. Enter the interest rate if the contribution is a loan.

Once you have disclosed a contribution on this form (Form 496), it is not necessary to report that contribution on any additional Form 496 filings you make.

**NOTE:** Late independent expenditures made and contributions received must also be reported on the next regular campaign statement you file. In addition, a Supplemental Independent Expenditure Report (Form 465) must be filed.
